#### 4. Project/Program Description:

Algebra Nation is an innovative, 100% Florida Standards-aligned teaching and learning system that is proven to improve student mastery of Pre-Algebra, Algebra 1, Geometry, and Algebra 2. Available online, anytime and from desktop, lap top, tablet, or mobile device, Algebra Nation is available to help a student right when they need it. Algebra Nation serves 100% of Florida school districts, with approximately 500,000 students and 20,000 teachers utilizing the platform each year. Students learn from their choice of dynamic "study expert" through engaging, impactful instructional videos. Algebra Nation also produces a workbook for Algebra 1, Geometry, and Algebra 2 that accompanies the videos and offers extra practice. They also can receive homework help after school on the Algebra Wall, a Facebook- style homework help line where they can reach tutors and other peers. The "Test Yourself" Tool provides students with hundreds of practice questions that emulate the End-of-Course exam.

#### d. What are the direct services to be provided to citizens by the appropriations project?

Free, 24/7 access for Pre-Algebra, Algebra 1, Geometry, and Algebra 2 students and teachers to the digital system that offers: 1,000 mathematics instructional videos; free after hours homework help line; interactive practice tool; adaptive, personalize learning tool to remediate pre-algebra and other critical math skills.

Teachers also have access to a custom-built teacher professional development network that provides free teaching resources, including videos, lessons, and activities, as well as opportunities to connect with other math teacher across the state. Algebra Nation also provides free professional development opportunities to teachers across Florida at no charge to them. 350,000 Algebra 1, Geometry, and Algebra 2 workbooks will be produced, printed, and shipped to students and teachers across Florida.

e. Who is the target population served by this project? How many individuals are expected to be served?

<u>Pre-Algebra</u>, <u>Algebra</u> 1, <u>Geometry</u>, and <u>Algebra</u> 2 students and teachers in 100% of Florida school districts and charter schools. An expected 500,000 students and 20,000 teachers will be served.
