#### 4. Project/Program Description:

This is the first phase of a 26 acre innovative complex that will seamlessly combine community engagement, science-based conservation, recreation and tourism in the form of a regionally-focused aquarium in the second busiest cruise port in Florida. When complete, the new complex is projected to have a total annual economic impact of \$85.5 million and support 937 jobs. In addition, construction of this unique institution will support another 469 jobs. This first phase will include a Community Conservation Center focused on Indian River Lagoon restoration efforts and an outdoor recreation area that includes a water park focused on the St. John's River watershed and educational excursions into the Indian River Lagoon.

#### d. What are the direct services to be provided to citizens by the appropriations project?

The Community Conservation Center will be a 15,000 square foot building with easy access off Route 528 with ample parking, perched on the edge of the Banana River. From along its restored shoreline, we can directly launch kayak and other boat tours into the Indian River Lagoon (IRL). The Center will be home to: accessible, understandable and entertaining permanent exhibits illustrating the challenges facing the IRL and the solutions at hand; changing exhibits featuring the work of researchers from local universities involved in saving the IRL; demonstrations of actions residents and tourists can take to limit their impact on the IRL; highly trained staff and volunteers who can help residents with conservation questions; lab and meeting spaces for visiting university and high school classes and local conservation groups; and a temporary holding facility for injured wildlife managed by the Florida Wildlife Hospital.

e. Who is the target population served by this project? How many individuals are expected to be served?

This facility will serve a mix of overnight tourists coming to Brevard County and Central Florida residents.

Because of its "gateway" location to Brevard County and open admission, a 1% capture of east bound cars on Route 528 would result in over 150,000 visitors annually. For budgeting purposes, this same number is being projected for the water park.

- f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?
  - We will keep hard visitor counts on both facilities, do qualitative research on the educational impact of the water park and document the conservation projects housed in the Community Conservation Center.
