#### 4. Project/Program Description:

The Lake County Veteran's Treatment Court [LCVTC] is a court-supervised program for those arrested in Lake County who have a mental illness, substance abuse, or other mental health condition related to their military service, who need treatment and other services, and who choose to participate in the LCVTC instead of having their case precede through the regular court process. The Lake County Veterans Treatment Court's mission is to promote public safety while supporting eligible veterans and their families through a coordinated effort among veterans' services, community services, and the court to leave no eligible veteran behind.

#### 11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The goals of the Lake County Veterans Treatment Court are to: 1) Reduce criminal recidivism 2) Facilitate participant sobriety 3) Reduce costs of criminal cases 4) Increase compliance of treatment and other court-ordered conditions 5) Improve access to VA benefits and services 6) Improve family relationships and social connections and 7) Improve life stability

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Veteran's Treatment Court integrates alcohol/drug treatment and mental health services into the justice system case process. Partnerships with stakeholders allow for a coordinated strategy for responses to participants' compliance. Veteran mentors and the court case manager assist participants with peer support, housing, employment linkages, job training, education, transportation, disability compensation claims, discharge status and other linkages available at the local, state and federal level. Contracted substance abuse and mental health counseling is provided to all participants. Alcohol and drug testing is completed to monitor and ensure abstinence. There is ongoing judicial interaction.

#### d. What are the direct services to be provided to citizens by the appropriations project?

The Lake County Veterans Treatment Court serves veterans in the criminal justice system and, therefore, does not provide direct services to citizens. However, Florida's citizens indirectly benefit from lower crime rates and the improvement of mental health and treatment outcomes of clients who successfully complete the program.

#### e. Who is the target population served by this project? How many individuals are expected to be served?

Eligible clients are Veterans, that have a documented substance abuse and/or mental health diagnosis directly related to their military service and are involved with the criminal justice system. Participants may be homeless and unemployed. The Lake County Veteran's Treatment Court expects to serve 75-100 individuals.

# f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The program will track eligible participants and success rates. Improved physical health through increased access to VA benefits will be measured with medical evaluations. Improved mental health will be measured by increased functioning scores using evidence based psychological assessments. Improved community safety will be measured by completed court sanctions and monitored through intensive case supervision. Education and employment assistance will result in improved economic self-sufficiency of program participants. Decreased recidivism will be measured with arrest data. Decreased substance abuse will be measured by random

urinalysis and successful completion of substance abuse counseling. Decreased court time and cost to the Judicial system will be measured through program participants being diverted from the traditional court process.
