

- 1. Title of Project: Tamarac The Boulevards Stormwater Drainage Repair and Pipe-lining

- 4. Project/Program Description:

The project provides immediate stormwater mitigation and water supply services to residents of Tamarac (Tamarac Lakes North community-The Boulevards), the City of Fort Lauderdale and Broward County. Specifically, a section of 30" corrugated aluminum drainage pipe collapsed as it was over 50 years old and deteriorated. The pipe is located only 25' away from existing homes, creating great logistics difficulties to enter, break ground and replace the pipe. To avoid the potential for private property damage, the collapsed pipe section was immediately cut-off and will be re-routed and located within the public right-of-way (local funds). Rather than destroying private property through digging, the remaining non-collapsed pipe will be inspected, point-repaired where possible, and replaced where necessary.

<u>The project provides for Storm water Mitigation for Tamarac, Fort Lauderdale and Broward County through (a)</u> the repair of a catastrophic failure in the Tamarac Stormwater System and (b) repair/replace of existing storm water pipe drainage system. The project also provides for two types of Water Conservation through (1) the rehabilitation of the Broward County water recharge system of the lakes in the Tamarac Lakes North residential community.

<u>There are three specific benefits/outcomes of the project are to (1) Prevent another catastrophic failure</u> within the existing City of Tamarac Storm water System (2) Preclude substantial private property damage from pipe excavation and another storm water system failure (3) Avert severe erosion issues that would harm both the environment and marine life within these lakes. Methodology: (1) Inspect all drainage pipe/Point-Repair damaged pipe where able/Replace non-repairable drainage pipe within usable current drainage system (2) Rehabilitation of the recharge system of several lakes in the Tamarac Lakes North residential community
