4. Project/Program Description:

Pine Lake Preserve Re-Hydration: This Hydrological restoration project will re-hydrate and re-establish hydraulic connectivity between the Imperial River and the undisturbed CREW wetlands which lie to the east of the preserve on the Corkscrew Swamp. Stormwater sheetflow generated by Hurricane Irma flowed across the 173 acre Pine Lake Preserve site and into the Lakes of San Souci neighborhood putting 2+ feet of water on the streets for 5 week, and flooding 3 residences. This project is designed to contain those flows onsite and direct them into 2 existing shallow lakes onsite and then into a severed tributary of the Imperial River. This tributary lies on the southern portion of the property and was severed from the Imperial River system in 1962 when the Kehl Canal was excavated. The channelization redirected the natural flow of water and starved the Pine Lake Preserve Property. In addition, a portion of the current flows from the Kehl Canal will be redirected into the tributary wh
