Improve vehicular driving experience. Add missing sidewalks. Provide traffic controls. Improve roadway system in support of local bus system and future (proposed) bridge replacement. Improve lighting.

e. Who is the target population served by this project? How many individuals are expected to be served?

Over 800 (students from elementary to high school, merchants, residents of all ages).

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The redesigned roadway will improve pedestrian connectivity, improve drainage, improve street lighting, add bus shelters, and landscaping. Items will be measured using Local Area Planning reporting standards. Replacement of an existing obsolete bridge will necessitate improving the approaches to the bridge to make sure drainage can be managed properly. The roadway re-work will address that deficiency as well.

g. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

\$1,000 per day (liquidated damages).
