The specific purpose is the measurable reduction of violence & crime in with an abnormally high rate of calls for law enforcement service, high unemployment, disproportionate rate of homicides, lack of business growth & development, disproportionate population under correctional jurisdiction and under utilization of job training and placement services, with a focus on areas designated community redevelopment areas.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Community development capacity of faith based and not for profit entities located within the effected area that has an established relationship with community stakeholders and law enforcement which enables the delivery and supports of job development, mentoring, internships, delinquency interventions for juvenile delinquents and community youth. In addition to youth engagement, provider agencies will be certified in Crime Prevention through Environmental Design (CPTED) performed by the Attorney Generals Office as a conduit to improving the relationship between the community and law enforcement.

Services will include direct and collateral youth case management, interventions and preventive support for primary youth as well as parent / guardian support. School and community collateral contacts will be regularly facilitated to promote improved, grades, behavior and attendance as an prevention/intervention as well as a monthly case asset and risk management review.

e. Who is the target population served by this project? How many individuals are expected to be served?

The target population are at-risk youth ages 13 to 18 years old whom resided in high risk communities including designated "slum & blighted" neighborhoods. 150 youth will be served annually.

The measurable outcome benefit will be assessed based on an analysis DJJ demographic data and law enforcement crime data as well as aggregated grades, behavior and attendance, job readiness and training outcomes.
