4. Project/Program Description:

Abe Brown Ministries, a collaborative member of Children in Hillsborough of Incarcerated Parents (CHIPS), provides an opportunity for children to participate in video visitation with their parents who are incarcerated. Every Monday at Abe Brown Ministries (ABM), children are able to speak with their parent live via video conferencing technology. The children and caregivers (optional participation) can take part in the video visitation at no cost. In addition to the video visitation, participants enrolled in the program have the opportunity to travel to the prisons once a quarter. Transportation and lunch are provided at no charge. The children and caregivers get the opportunity to physically interact with the incarcerated parent during the visit, which consists of games and activities.

a. What is the specific purpose or goal that will be achieved by the funds requested?

To expand services to for children to maintain the bond with their parents incarcerated throughout the state of Florida. The program is open to children who are under the age of 18 years old and have an incarcerated parent at one of the participating state prisons. The child(ren) must reside in either Hillsborough, Pinellas, Pasco, Polk, or Hernando County. The child must not be the victim of the parent's crime, and the parent must still have their parental rights.

1) Weekly video visits between children under 18 and their incarcerated parents 2) Quarterly family bonding trips with children under 18, their caregivers, and their incarcerated parents 3) Referral services and social support services to children under 18 with incarcerated parents and their caregivers

d. What are the direct services to be provided to citizens by the appropriations project?

1) Weekly video visits between children under 18 and their incarcerated parents. 2) Quarterly family bonding trips with children under 18, their caregivers, and their incarcerated parents. 3) Referral services and social support services to children under 18 with incarcerated parents and their caregivers.

e. Who is the target population served by this project? How many individuals are expected to be served?

Elderly persons, persons with poor mental health, persons with poor physical health, economically disadvantaged persons, at-risk youth, preschool students, grade school students, and high school students. The target population to be served is 51 - 100 individuals.

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

1) Improve mental health: To increase the familial bond and enhance the children's coping skills related to the trauma of being separated from their incarcerated parent. Children will demonstrate an increase in the familial bond and attachment to parent evidenced by self-report and clinical observation. Children ages 5-17 will demonstrate an increase in positive coping skill evidenced by Kid Cope Scale score, a modified Kid Cope Scale score or emotional well-being skills. 2) Stress levels for caregivers will be reduced: Caregivers will demonstrate a reduction in their stress levels as evidenced by a decrease in their Perceived Stress scale score. 3) Divert from Criminal/Juvenile justice system: Inmates will have a greater sense of attachment to their children as well as decreased concerns regarding their child's well -being. Inmates will demonstrate an increase in attachment to their children and a decrease in their concerns as evidenced by their score on the Inmate Questionnaires.
