The City of South Daytona has purchased 2.26 acres of vacant land adjacent to two (2) existing ponds on 1.37 acres of land. The acquired lot and existing ponds will be excavated to make one large wet detention system. The project will provide water quality treatment of stormwater runoff prior to it entering the Halifax River, an impaired waterway, and the Intracoastal Waterway. It will provide greater storage capacity to improve local drainage/reduce flooding.
