4. Project/Program Description:

TMF STEM & Youth Empowerment Summit is an annual 2 day conference for Miami & Broward County middle and high school youth that teaches conflict resolution, gun violence prevention, self-esteem, and empowers the youth to create solutions for problems in their communities with the guidance of a distinguished panel of professionals, and university and high school leaders. In addition previous featured speakers such as the US Secretary of Education and the Deputy Secretary of the Department of Education have informed students of educational opportunities in STEM. 10 students who attended the 2nd conference held this year as well as the 2018 STEM & Y.E.S. Summit will be sponsored to attend a week long STEM Camp. They will be paired with a University STEM student in their area of interest prior to attending camp. They will continue to be mentored by the student after arriving home. Students will speak with University counselors to learn the academic areas of coursework they need.

2500 students will attend a 2 day youth summit with break out sessions on reducing teen & gun violence; conflict resolution workshops, educational forms and planning, etc. In the summer 10 students will attend a 7 day STEM & Robotics Camp (Embry Riddle) where they will meet their Year-Round University Mentors for STEM camp participants.

Improved Quality of education; enhanced economic Self-sufficiency; divert participants from Juvenile/Criminal Justice System; Decrease youth violence among participants. The outcomes will be measured by baseline survey and counselor information. The Trayvon Martin Foundation will monitor participants progress through future surveys; testimonials provided by participants; follow ups and Exit interviews.
