Museum exhibits - cultural and history exhibits for the public on Miami's music history, Civil Rights, and African American Heritage. Community outreach - family and community events to promote community heritage and encourage historic preservation. Adaptive re-use - build out of the facility's remaining unfinished spaces into a dance and music studio that will host arts programs for the community.
