Measure the average delay getting to and from the Port of Tampa through the Interchange during the morning and afternoon peak hours. 2. The change in travel time to and from the Interstate to the Port of Tampa to increase accessibility to a major activity center. Direct measurement of the time to travel from the Port of Tampa entering to the mainline travel lanes of the Interstate.

Withholding of funds.
