1. **Title of Project:** City of Oldsmar-Harbor Palms Infrastructure Improvement Project

4. **Project/Program Description:**

Oldsmar's underground utilities are over 40 years old. Malfunction due to age and condition is creating excessive wear on roadways and sidewalks due to major distress from subsurface water damage. Sanitary sewer and stormwater improvements will further the objectives of the Pinellas County Wastewater/Stormwater Task Force to improve the maintenance and operation of wastewater and stormwater systems. This request for \$3,195,000 is to cover the cost of sanitary sewer and stormwater improvements in the first phase of the project. The construction of the second phase of this project is estimated at \$3,195,000. Additionally, the City will be funding \$3,500,000 for improvements to the potable water system.
