1. Title of Project: Juvenile Reentry Virtual Interviewing Prog.-JRVIP

4. Project/Program Description:

The Juvenile Reentry Virtual Interviewing Program is used as a component of the offender's pre-entry services. JRVIP provides job interview practice by using customizable virtual humans as potential employers. The diversity of training options that the system provides using six avatars, three behavioral dispositions (soft-touch, neutral, and hostile), and interchangeable backgrounds (including a restaurant, warehouse, office, break room, and hotel) creates a variety of interview experiences. These scenarios allow for progressive difficulty and customizable training geared to the needs of the user. JRVIP is a novel approach to support youth's successful re-entry into the community and to reduce the rate of recidivism using virtual technology.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

Offenders often report being stressed when interviewing for a job especially when asked to formulate responses discussing their incarceration history. Getting a job can make a big difference for an offender, their families, and their community. Employment is key to a successful transition. However, the job interview can present the biggest challenge to employment in this population. This issue is addressed with vocational interview skill training, delivered as part of the offender's pre-entry services. The specific goal will be to reduce recidivism, by gaining employment.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The JRVIP coordinator will meet with youth before beginning the Virtual Interactive Training Agent (ViTA) interview process. After the initial meeting, the youth shall participate in his or her first video recorded ViTA interview. After the interview is conducted, staff will review the recorded interview to provide feedback, coaching sessions will be provided, and specific areas of improvement will be identified. Within a one - three month period, there will be a second, third, fourth, and final face-to-face interview with the youth.

c. What are the direct services to be provided to citizens by the appropriations project?

The ViTA is a virtual-reality practice system initially designed to build job-interviewing competence and reduce anxiety in persons on the Autism Spectrum and with U.S. Veterans. The Dan Marino Foundation has customized the content of this system to address the challenges that are specific to offender populations. The program will teach the students to effectively communicate during a job interview.

d. Who is the target population served by this project? How many individuals are expected to be served?

Youth between the ages of 14 to 21 who are currently detained in a Florida residential facility or detention center, or attending a prevention or probation program, be on community supervision or in a diversion program residing in the State of Florida. These services are delivered to the youth as a condition of his or her community supervision or as part of the diversion program's individualized service plan. There will be 1500 or more interviews to assist between 200 and 300 youth.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Employment is shown as a factor leading to reduction in recidivism. Isolation, depression, stress, and mental health issues and the associated treatment costs can be reduced with successful implementation and integration. More career education combined with life and soft skills will lead to decreased antisocial behaviors and improve functioning levels (e.g. employment, school, and family relationships). Outcomes will be measured by: task analysis, progress notes, and job development logs. Satisfaction surveys will be completed by participants, and a database will be maintained with the results. Pre- and post-measures will be conducted in the areas of self-determination, self-advocacy, and employment-related social skills. Measurable outcomes include: Attendance/Program Completion - 90% of participants will successfully complete the program; 100% of youth will not recidivate within one year after program completion.
