#### a. What is the specific purpose or goal that will be achieved by the funds requested?

The purpose is to continue, enhance and expand the services provided to the economically disadvantaged residents of the residents of Sweetwater and surrounding low income areas.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

For the children from K-12 Grades: After School Tutoring, Taekwondo, Dance, Archery, Piano & Guitar Classes. College SAT Prep classes.

#### c. What are the direct services to be provided to citizens by the appropriations project?

TUTORING: 130 children tutored w/1 teacher. Need additional Teacher. FIU students volunteer as tutors so we c/n demand their attendance. We currently have 4 old desktop computer that the tutors use to help these students navigate subjects they are studying in school. Need to purchase 4 new laptop computers w/updated educational programs & more memory, enabling our students to develop computer knowledge and not fall behind their peers. College SAT Prep Classes. Need: Teacher & Prep Books.



### d. Who is the target population served by this project? How many individuals are expected to be served?

Children from 3-18 years old. Undeserved and/or At Risk youth, Economically Disadvantaged Children from the Sweetwater Community. We expect to serve around 300 children.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Overall, the main benefit that we aim for from all our programs are to give economically disadvantaged children the same educational and physical fitness opportunities granted to any child. Our free tutoring program helps children unable to afford a private tutor with additional instruction or educational guidance. Success is measured w/their academic improvement. Our three current Education through Physical Education programs (Taekwondo, dance and archery) are aimed at improving Physical and mental health, self-discipline, improving motor skills, self- esteem and confidence. Although it's difficult to measure outcome, we base much of the success w/our retention rates and results of participants in local & state competitions. Also , for students with discipline problems at home or in school, we measure conduct improvement in their schools and home. Our upcoming music program (piano and guitar) aims to extend these same benefits to musically-inclined children in our community.
