4. Project/Program Description:

Breezeswept Park Estates is a subdivision within the City of Plantation that is suffering from aging pipes and ruptured water mains. The City is undertaking a phased approach at replacement of the area's water infrastructure. This local funding initiative request is for Phase B of the project and will aide replacement of 11,550 linear feet of water main that has reached its operational life, does not meet water flow capacity and has been confirmed through testing to have galvanized water services and ruptures in cast iron water mains. The project protects water quality, increase water flow and decrease service interruptions. In addition, the installation of newer materials provide a longer service life than previous material available at the time of the original development of these subdivisions.
