## **11.** Program Performance:

#### a. What is the specific purpose or goal that will be achieved by the funds requested?

Welding and electricity programs will be expanded and upgraded to allow RIVEROAK Technical College to serve additional enrollees in the manufacturing career cluster based upon local and regional workforce needs as identified by the Targeted Occupations List (TOL) for the Suwannee county service area. Construction of a new allied health simulation laboratory would afford students in all health programs opportunities to work with state of the art medical equipment and technologies to better prepare them for workforce and provide additional classroom space, as all programs are currently at enrollment capacity.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

RIVEROAK Technical College will provide welding and electricity instruction using the most up-to-date technologies. With classroom renovation, programs will be able to accept additional student enrollment, as at this time there are waiting lists due to the limited space and electrical capacity available for instruction and equipment use. Allied health students will utilize current technologies and equipment necessary for workplace readiness and success.

#### c. What are the direct services to be provided to citizens by the appropriations project?

RIVEROAK Technical College will provide quality career and technical education programs focusing upon manufacturing and allied health, as these are identified as critical need areas by CareerSource. Students will also receive support services including, but not limited to career readiness skills, financial literacy, career counseling, on the job training, and job placement assistance.

#### d. Who is the target population served by this project? How many individuals are expected to be served?



Targeted populations will include: economically disadvantaged, displaced homemakers, jobless individuals, unskilled adults, and dual-enrolled secondary students. Number of individuals expected to be served yearly in electricity, welding, and health care programs is projected at 235.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected benefit of this project will be an increase of advanced educational opportunities and job placement in manufacturing and health care fields. Outcome will be measured utilizing a variety of local and state data to include: Department of Economic Opportunity regional data, Annual Council on Occupational Education Report for RIVEROAK Technical College, employee verification forms, student surveys, CareerSource Regional data, and State FETPIP job placement data.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Suwannee County School District will utilize district, state, and federal guidelines/policies for contractual agreements with vendors (i.e., building contractor) to ensure deliverables are appropriately met.
