a. What is the specific purpose or goal that will be achieved by the funds requested?

The goal is to provide a safe walkway for the pedestrians, especially the elementary school children, who regularly walk along County Line Rd. There is currently no sidewalk along County Line Rd and the school children often need to walk in roadway to get to and from school. County Line Rd is a heavily traveled east-west connector road.

- b. What are the activities and services that will be provided to meet the intended purpose of these funds?
 - The proposed sidewalk will keep the pedestrians and school children from walking in the roadway providing them a safe way to walk along County Line Rd between 48th and 56th avenues.
- c. What are the direct services to be provided to citizens by the appropriations project?
 - Protection and improved life and health safety for the citizenry, and school children to have a safe walkway.
- d. Who is the target population served by this project? How many individuals are expected to be served?
 - Primarily the elementary school children, but also the general population that live along County Line Rd where there are numerous apartment buildings and a large number of residents in low income housing. Three to four thousand residents and school children.
- e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?
 - Pedestrian safety. The town will monitor and record traffic accident reports in the area to measure the success of this project.
