Recognizing its vital importance to the State of Florida, the Joint Institute for Gulf of Mexico Studies preserves and promotes the Gulf via cost-effective collaboration and rapid response among academia, government, and industry in the areas of marine and life sciences. The Institute will create an infrastructure for collaboration through a dedicated staff focused on identifying innovative joint opportunities, developing collaborative agreements, and facilitating communications among organizations and to the public. The Joint Institute would facilitate resource sharing, and data gathering and management. This would provide the foundation to enable rapid response to emerging or critical issues related to the Gulf, such as red tide, coral restoration and aquaculture. Finally, the presence of the Joint Institute would serve as a catalyst for economic development through research commercialization, education and workforce development programs.
