1. Title of Project: UF- Utilities/Infrastructure Improvements

4. Project/Program Description:

This is a request to supplement the annual PECO appropriation for Maintenance, Repair, Renovation and Remodeling (Sum-of-the-Digits Formula) in order for UF to address critical deferred maintenance issues as identified by independent consultants. One of the oldest public universities in the State, UF has a 36-year average building age for its 900 buildings which have an actuarial replacement value exceeding \$4B. The State of Florida owns the majority of State University System land and associated buildings; therefore, investment by the state in this infrastructure is vitally important. In the past 19 years, UF has received an average of \$12 M annually from the Sum-of-the-Digits PECO formula. Appropriations have vacillated from a low of \$2.7M in 2012-13 to a high of \$24.9M in 2016-17 to address our \$50M annual need. In 11 of the last 19 years, the Legislature has been instrumental in appropriating supplemental funding, to UF, for identified maintenance requests such as this.

a. What is the specific purpose or goal that will be achieved by the funds requested?

UF "Utility/Infrastructure Improvements" projects are a continuous effort of corrections, expansions, and modifications to major campus systems in support of the university's educational and research missions. Funds will be used to address critical needs as identified in the 2016 comprehensive Facility Assessment of campuswide facilities conducted by independent consultants:Intelligent Systems Engineering Services (ISES)

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Renovations/repairs will address: sanitary sewer; steam; HVAC systems & energy management control systems; chilled water & controls; storm water runoff; telecommunications; leaking/failing roofing systems; potable water; irrigation/reclaimed water; & roadway systems, etc.

c. What are the direct services to be provided to citizens by the appropriations project?

Repairs as stated above. Example: Failing Chiller- this could render an air conditioning system inoperable for days, affecting the delivery of education to students, the protection of sensitive research subjects and projects; the health and experience of medical patients visiting UF from around the state and country.

d. Who is the target population served by this project? How many individuals are expected to be served?

Thousands of Students, faculty, staff, and visitors, including medical patients, traversing UF properties will experience a campus environment that is safe, attractive and accommodating, and one that is expected from a Preeminent University.

Students, newly-hired faculty, potential faculty, whom UF is recruiting, will arrive on campus with safe and appropriate classrooms, research and teaching labs, enhanced by technology as required to support the teaching, research, extension, and patient care missions expected of a major Preeminent University. Measurement: Inspection forms are completed for all major components of renovation/construction project; UF uses independent consultants (Commissioning Agents) to perform inspections on behalf of the university.
