This initiative will create a Mental Health/Substance Abuse Pretrial Diversion Pilot Program for Okaloosa and Walton Counties based on a modified version of the highly successful Miami Dade County (Eleventh Judicial Circuit) Criminal Mental Health Project. The purpose will be to reduce the number of defendants transferred to the state forensic hospitals and delays in resolving criminal cases and provide for a continuum of care.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

This proposal is the result of more than two years of planning and stakeholder involvement for an initiative to provide pre-offense services and for pre- and post-booking diversion for appropriate people with misdemeanor and low level felony charges from the criminal justice system as well as post-release wraparound services to those who are released from custody.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Using the Memphis Model of CIT (crisis intervention training) contact, subjects of 911 mental health calls will receive a personal contact that will focus on initiating rapport, evaluating the need for crisis intervention either by the new mobile response crisis team or Baker Act/Marchman Act admission, securing a signed release of information and evaluation of the appropriateness of a Red Flag weapon petition. If an individual is arrested, they would be evaluated by the LCSW at Booking or by Pre-Trial Services prior to First Appearances.

c. What are the direct services to be provided to citizens by the appropriations project?

Mentoring, assistance with appointments, benefits, housing, medicines, etc. It is expected a relationship will be established with a Federally Qualified Health Center (FQHC) to provide low cost medicines that are currently not available. Post release services would mirror diversion services for defendants who have received services whilst incarcerated.

d. Who is the target population served by this project? How many individuals are expected to be served?

Provide pre-offense services and for pre- and post-booking diversion for appropriate people with misdemeanor and low level felony charges from the criminal justice system as well as post-release wraparound services to those who are released from custody. Potentially 100-200 individuals, however the entire surrounding area will stand to benefit.
