- 1. Title of Project: Feeding Hungry Seniors & Veterans Phase II

- 4. Project/Program Description:

The Nassau County Council on Aging's NCCOA "Feeding Hungry Seniors and Veterans" project will staff, plan, prepare, serve, and deliver meals to Seniors and Veterans residing in Nassau County. A commercial generator will be purchased in the event of a natural disaster or loss of electricity. In the latter instance, the entire community will have access to hot, nutritious meals during a time of need. In 2018, NCCOA received an appropriation from the State through the Legislature to build and equip a commercial kitchen. The project has been completed. This Bill was introduced by Representative Cord Byrd and strongly supported by Senator Aaron Bean. The kitchen is now ready to go to the next level in the continuum of care for Seniors and Veterans, which includes the delivery of meals to disabled Veterans. It is expected that up to 10,000 meals per month will be made available to these vulnerable populations. More than 400 are on the waiting list for meals in Nassau County.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The goal attained will be a commercial kitchen in full operation which will complete phase II of the original State-funded project. Approximately 10,000 meals will be prepared monthly to feed Nassau County Seniors and Veterans in need.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Experienced staff will be hired to carry out the goals of the request. The activities will include planning, preparing, serving, and delivering meals to the County's most vulnerable Seniors and Veterans, including disabled Veterans.

c. What are the direct services to be provided to citizens by the appropriations project?

Nutritional meals approved by dietitian for caloric content and nutritional value.

d. Who is the target population served by this project? How many individuals are expected to be served?



Target populations will be Seniors and Veterans. At least 2,000 seniors and veterans will benefit from the services over a 12 month period. It is also anticipated that caregivers who are seniors can also benefit, if funding is appropriate.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The benefits will be healthier, happier seniors and caregivers with an expanded life span and enhanced mental clarity. This outcome will be measured by creating, reviewing, and updating case care plans; home visits; medical reports; and through conversations with caregivers and the beneficiaries themselves (Seniors and Veterans).

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

The penalties will begin with seniors not being fed. There will be increased incidences of medical problems and malnourishment amongst these vulnerable populations, which can lead to premature death and other health issues.

The Nassau County Council on Aging, Inc., is a private non-profit, thus, there is no owner/owners. The Board of Directors and CEO have no monetary ownership of the building. The fixed capital outlay request is a commercial generator needed in the event of a natural disaster or loss of electricity.
