#### 11. Program Performance:

#### a. What is the specific purpose or goal that will be achieved by the funds requested?

Funds will be distributed to public schools based on performance of AVID students and spent per attached proviso titled Attachment A. Funding earned by public schools will be used to support the school in implementing its AVID system with fidelity resulting in increased student performance on the algebra 1 taken by middle school students, and geometry end of course exams taken by middle school and 9th grade students; AP, IB, and AICE exams in high school grades; and provide support for increased college readiness and persistence.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The funds will provide professional development and training on AVID strategies for program coordinators, teachers, and tutors. The funds also provide compensation for tutors that assist students during the school-day in the AVID elective, and access to transportation for AVID students so they have the ability to visit a college campus.

#### c. What are the direct services to be provided to citizens by the appropriations project?

The appropriation directly provides tutoring services for assist students during the school-day in the AVID elective, access to college visits for AVID students, and an improved AVID experience for students through teacher professional development.

- d. Who is the target population served by this project? How many individuals are expected to be served?

  Over 1,000 middle and high school students.
- e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The benefit is increased college readiness and college attendance among students. The methodology is performance-based, as specified in the attached proviso, according to the following exams: a score of 4 or

higher on an International Baccalaureate subject examination; score of 3 or higher on the College Board Advanced Placement Examination; score of E or higher on an Advanced International Certificate of Education subject examination; or, for students in grades 6-8, who receive a passing score on the algebra end of course examination; or, for students in grades 6-9, who receive a passing score on the geometry end of course examination.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Funds are not distributed unless AVID students meet the performance standards.
