#### 4. Project/Program Description:

The third phase of the Florida Horse Park will continue to improve the infrastructure, increase the hurricane evacuation footprint and build new classroom space/museum/administrative building. With approximately 80,000 visitors from across the state and nation annually, the FHP provides the state and community with a recreational facility capable of hosting a diverse series of events including equine sports, educational opportunities, community events, and an animal-safe storm evacuation site. In 2017, as Hurricane Irma barreled toward the state, the FHP saved countless animal and human lives as the evacuation site was at capacity. In 2018, the FHP collected and distributed food, hay and building supplies for the victims of Hurricane Michael.

#### a. What is the specific purpose or goal that will be achieved by the funds requested?

Property is owned by the Florida Department of Environmental Protection, part of the Florida Greenways, the horse park has a state-wide impact as it provides a critical safe place to shelter humans and animals in a state of emergency. Additionally, the park facility is used to support national and international equine events, interscholastic sports, and education opportunities.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The Florida Horse Park serves both residents and tourists from across the state and world. Activities and services include, but not limited to, equine competitions and events, youth rodeos, interscholastic sports, historic (war) re-enactments, car shows, RV shows hot air balloon festivals, Future Farmers of America, educational agriculture events, and a safe environment for the public.

- c. What are the direct services to be provided to citizens by the appropriations project?
  - Services include, but not limited to recreation, safety, housing and educational.
- d. Who is the target population served by this project? How many individuals are expected to be served?

Students of all ages, General Public, Competitors and Athletes. Approximately 100,000 are expected to be served. A 2016-17 study by DACS showed that for every dollar the state invests in the Florida Horse Park, it results in a \$21.83 return on investment via economic activity.

The benefits will increase the parks ability to provide a critical safe place to shelter humans and animals in a state of emergency and increase the number of events held at the park, ultimately growing the number of visitors to the park and Florida. This has a state-wide impact that serves both humans and animals, and in the 2017 hurricane, countless animal and human lives were protected through the use of the FHP as a hurricane shelter.
