11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

FDEP water quality improvement, ecological and recreational enhancement, and regulatory compliance for three waterbodies that that been identified as not meeting their designated uses (Class III recreational uses). These waterbodies are: Lake of the Woods, Lake Howell and ultimately Lake Jesup.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The design and construction of structural BMPs (best management practices) to reduce the amount of stormwater pollutants reaching the impaired waterbodies.

c. What are the direct services to be provided to citizens by the appropriations project?

Enhanced and improved ecological and recreational uses.

d. Who is the target population served by this project? How many individuals are expected to be served?

Since Lake Jesup is a large lake of regional significance and use, the population that will be served and benefit from these projects will be greater than the population of Seminole County (>450,000 people).

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Improved water chemistry, biology and ecology is the expected outcome. These matrices will be measured and assessed using FDEP SOP (standard operating procedures) for water chemistry and biology.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

These BMPs are standard accepted methodologies for reducing stormwater pollution, therefore, the expected outcome will be improvement in water quality. If contract deliverables are not met, then reimbursement for such activities should not occur.
