4. Project/Program Description:

The proposed project will harden a critical facility within the City of Oakland Park. The two-story 33,000 square foot structure is home to the Broward County Sheriff's Office, Oakland Park Station and the City's Engineering and Community Development Department. The building was originally constructed in 1982 and purchased by the city in 2007. While repairs and improvements have been made, the structure needs major renovations to meet current codes and provide protection during and after a natural disaster, specifically a wind speed event. The project will harden the structure by installing a new roof as well as impact windows and doors.

#### 11. Program Performance:

#### a. What is the specific purpose or goal that will be achieved by the funds requested?

The primary protection provided by the project will be from wind damage. The installation of a new roof will represent the foundation for the retrofit of the facility. In order to protect all of the openings of the buildings all the windows and doors will be replaced with impact materials. The roofing, window, and doors will meet current codes for the area providing protection for 170 mph wind speeds. These mitigation activities will ensure an immediate response after a disaster.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Once complete the facility will be able to provide office and work space for the city's Engineering and Community Development Department as well as the Broward County Sheriff's Office.

#### c. What are the direct services to be provided to citizens by the appropriations project?

The City of Oakland Park Engineering and Community Development (ECD) Department takes up the largest portion of the structure. The office building is home to the department that oversees the following divisions: building & permitting, community enhancement, planning and zoning, engineering and construction development. All of these divisions are critical parts of city operations and play an important role in planning, responding, and recovering from a natural disaster such as a hurricane. With a wide range of responsibilities from comprehensive and emergency planning, facility management, capital improvements to code enforcement/permitting the ability of the divisions and their staffs to resume operation immediately after a storm is a priority. The structure is also home to the Broward County Sheriff Department which provides public safety for the city. The site is home to a captain, two lieutenants, seven sergeants, 77 deputies, and administrative personnel.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The facility will allow both the city staff and the Broward County Sheriff's Office to effectively serve the entire Oakland Park community during and after a natural disaster such as hurricane. The City of Oakland Park is home to over 40,000 residents and consists of wide range of incomes, races, and age groups.
