11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The purpose of this program is to address the issue of vulnerability to financial predators and wealth disparity in immigrant communities by increasing the financial literacy, awareness of financial products, and free tax preparation for eligible low and moderate income Haitian families in Miami-Dade County.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The program will provide three main services : (1) tax preparation as well as tax return amendments , (2) Oneon-one financial coaching with a focus on issues such as credit building and saving for homeownership, college, and retirement. (3) Education on financial topics via Haitian Creole media about viable financial products and services and to protect them from tax refund scams, predatory lenders, and investment scams.

c. What are the direct services to be provided to citizens by the appropriations project?

The program will offer free tax preparation services to a minimum of 600 clients; financial coaching will be offered to all clients and anticipate that 300 individuals will be engaged in long-term financial coaching. Finally, community residents will gain increased awareness of asset building products such as IRAs, savings bonds, and children's savings accounts; as well as asset protection tools such as wills and medical proxies, among others.

d. Who is the target population served by this project? How many individuals are expected to be served?

This program seeks to financially empower immigrant families in Miami-Dade County, specifically targeting Haitian immigrants, who are at greater risk of being left out of the financial mainstream and are also highly



vulnerable to predatory financial products and services. Sant La seeks to target Miami-Dade County's racial and ethnic groups, particularly the Haitian community. Sant La expects to serve 300 households directly, and to reach 100,000+ Haitian households via media, including a weekly Creole-language television program, Teleskopi. Miami-Dade's Haitian population is conservatively estimated at 128,000, largely immigrants.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Sant La seeks a long term impact on the Haitian community by guiding individuals and families to solid and valuable financial services and to help them avoid dangerous and predatory practices. Since Sant La became an IRS-certified VITA site in 2013, they have prepared more than 10,000 returns. The efforts have increased the number of Haitian families filing taxes to claim the earned income and child tax credits, if they are eligible. These returns represent over \$10 million reinvested in the local economy, increasing assets and investing in businesses which are Haitian-owned and/or serve the Haitian community.
