Title of Project: Hillborough Community College (HCC) Apprenticeship - Tampa Bay

4. Project/Program Description:

Hillsborough Community College (HCC) is one of the largest post-secondary providers of registered apprenticeship training programs in Florida. Apprenticeship programs are highly structured "earn and learn" opportunities that combine a maximum of 2,000 hours of on-the-job training with a minimum of 144 hours of classroom related instruction. In 2018-2019, HCC will invest \$945,000 in its apprenticeship programs to train approximately 700 students. In spite of this significant investment, there remains a critical shortage of skilled labor that is challenging the region's ability to launch and sustain large scale economic development projects. In 2018, there were 5,346 job openings in the building and constructions trades in Hillsborough County (Source: Career Source Tampa Bay 2018-19 Regional Targeted Occupations List). Hillsborough Community College is proposing to expand the enrollment in its apprenticeship programs to 1,000 students to address the skilled labor shortage.

a. What is the specific purpose or goal that will be achieved by the funds requested?

The goal of the project is to expand the enrollment capacity from 700 to 1,000 apprentices for the purpose of addressing an immediate need of skilled labor in the building and construction trades.

- b. What are the activities and services that will be provided to meet the intended purpose of these funds?

 Program expansion through increased training and education opportunities.
- c. What are the direct services to be provided to citizens by the appropriations project?

The citizens of Florida will receive expanded opportunities for high-skill "journeymen" training and apprenticeships for construction trades such as carpentry, electrical, plumbing, HVAC, sheet metal fabrication, and fire sprinkler installation.

- d. Who is the target population served by this project? How many individuals are expected to be served?

 Jobless persons, economically disadvantaged persons, high school students, university/college students, and veterans. Program funding would allow HCC's 46,000 students the opportunity to enroll in the program.
- e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Improving quality of education will be measured using HCC's enterprise system. Student performance data will be collected to include pre and post basic skills test results and the number of certifications/licenses earned. The benefits of increasing or improving economic activity, creating specific immediate job opportunities, and enhancing specific individuals' economic self sufficiency will be measured by the number of residential and commercial building permits and tracking pre and post employment data related to the construction sector.
