Community development capacity of faith based and not for profit entities located within the effected area that has an established relationship with community stakeholders and law enforcement which enables the delivery and supports of job development, mentoring, internships, delinquency interventions for juvenile delinquents and community youth. In addition to youth engagement, provider agencies will be certified in Crime Prevention through Environmental Design (CPTED) performed by the Attorney Generals Office as a conduit to improving the relationship between the community and law enforcement.

  Youth whom reside in "Slum & Blighted" high calls for law enforcement service communities. Approximately 250 youth & families will be served.

The determination of successful outcomes will be through the utilization of delinquency recidivism data specific to DJJ recidivism and prevention standards.
