PowerNet of Tampa - partnering with Hillsborough Ex-offender Reentry Network, Corporation to Develop Communities of Tampa, University Area Community Development Corporation, Abe Brown Ministries, Tampa Bay Academy of Hope and Florida Department of Corrections - will engage 390 inmates in a rehabilitation and research protocol utilizing a state-of-the-art web-based data collection, resource management and reporting system. The database will be populated with profiles of willing HC inmates prioritizing those assessed as high risk with violent convictions. This system will encourage an optimal level of cooperation, coordination and collaboration between law enforcement, criminal justice, social services, employers, landlords, faith-based and other community volunteers. The incentive for using this system is: 1) improved the outcomes for the individuals, families and neighborhoods affected; 2) real-time statistical reports on programmatic progress and service delivery; 3) increased competitiveness of local providers to attract and maintain regional and national funding; and 4) improved public safety and overall quality of life throughout HC.

a. What is the specific purpose or goal that will be achieved by the funds requested?

The primary purpose of Operation Empower (OE) is to demonstrate the effectiveness (psycho-social rehabilitation and socio-economic reintegration) and cost savings (familial and monetary) of introducing a robust, high capacity state-of-the-art system for managing information and communication between service providers and criminal justice administrators that can support a comprehensive, countywide, criminogenic need responsive continuum of care (programs, services and resources) for adults returning to Hillsborough County (HC) from the Florida Department of Corrections (FDC).

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The Operation Empower "Reentry Information Management System" (RIMS) support includes: 1) secure, qualified and HIPAA compliant access to a client intake, case management, client referral and continuum of care services; 2) secure, qualified and HIPAA compliant access to a database of screened, criminogenically assessed and motivated FDC inmates returning to HC within the next 10 years; 3) full, unlimited, no-cost, user-friendly access to up-to-date, web-based list of qualified programs, services and resources for individuals with criminal records and their families; 4) full, unlimited, no-cost, user-friendly access to up-to-date, web-based public service announcements related to adult and youth criminal justice events, community meetings, legislation and other matters of importance in Hillsborough County; 5) full, unlimited, no-cost, user-friendly access and links to an updated library of reentry research, best practices and statistics from national, statewide and local private and pub

c. What are the direct services to be provided to citizens by the appropriations project?

PowerNet of Tampa - - will engage 390 inmates in a rehabilitation and research protocol utilizing a state-of-theart web-based data collection, resource management and reporting system. The database will be populated with profiles of willing HC inmates prioritizing those assessed as high risk with violent convictions. d. Who is the target population served by this project? How many individuals are expected to be served?

The target population would be medium to high risk men and women and those with violent convictions in their past who are returning to Hillsborough County. There will be at least 390 individulas served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected benefit of the experiemental group will be at least a 25 percentage point reduction in recidivism as compared to the control group. The evaluation of the proposed program has two distinct but interrelated components: a process evaluation (fidelity assessment) and an outcome evaluation. The outcome evaluation will utilize a randomized experimental design with blocking on level of risk. Randomized experiments are widely considered the "gold standard" of evaluation research due to their high levels of internal validity (Dunning, 2012; Murnane & Willett, 2011; Shadish et al., 2001). The reason that randomized experiments have high internal validity is that assignment to the treatment and control groups is exogenous—meaning that

respondents in the treatment and control groups are equal in expectation on all variables, even those that are unobserved. Dr. Sylvie Narr will be responsible for the fidelity assessment and staff training.
