ZooTampa is the only manatee rescue and recovery facility on the west coast of Florida. To date, we've treated more than 450 manatees at a cost of more than \$1,000,000 each year. Currently, these transfer and releases require our staff to rent a vehicle large enough to hold a full grown manatee. Transport requires our staff to have access at all times and many rental vehicles aren't equipped to manage that. We are requesting funding for a box truck to be used for manatee rescue and release.
