1. Title of Project: Water Certification Job Ready Pilot Program

4. Project/Program Description:

This program is to develop and implement a one-to-two year vocational program, as a collaboration between Pinellas County Utilities and a local educational institution. Students with a high school education, or a General Educational Development Degree (G.E.D.), will be able to obtain a Florida State certification as water/wastewater treatment plant, distribution system, and collection system operators. The program will consist of four main units: 1) general information and worker and environmental safety; 2) the characteristics, operation, and maintenance of potable water distribution systems; 3) sanitary sewer and forcemain collection systems; and 4) reclaimed water distribution systems. This course will incorporate 650 hours of classroom and select field instruction. Completion of this program will allow job-ready students immediate employment opportunities in the water resources field within the Tampa Bay area and region-wide.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The purpose of this program is to train high school (or equivalent) graduates in order to obtain Florida State certification as water/wastewater treatment plant, distribution system, and collection system operators. The resulting job-ready program graduates can then seek immediate employment opportunities in the water resources field in order to fill the increased job demand within the Tampa Bay area.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Program students will receive quality training, developed by educators and conducted by professionals consisting of four main job functions: 1) general information and worker and environmental safety; 2) the characteristics, operation, and maintenance of potable water treatment systems; 3) wastewater treatment systems; and 4) water and wastewater distribution and collection systems. This course will incorporate both classroom and field instruction.

c. What are the direct services to be provided to citizens by the appropriations project?

Florida citizens will benefit from having certified, professional water and wastewater system operators. This professional-level service will result in the provision of safe and uninterrupted water service to citizens and the protection of Florida's environment from spills and overflows due to poorly maintained or operated infrastructure.

The target population to be directly benefited by this program are job-seekers with a high school education (or equivalent) that are seeking training for a full time career. The initial class size will be limited to 12 students.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This program will benefit both the students directly with regard to increased job opportunities, as well as the citizens generally, in terms of quality water and wastewater service and environmental protection. The best measure of these outcomes will be the passage rate of the program graduates on the Florida Water and Domestic Wastewater Operator Certification Exams.

The suggested penalties for failure to meet the program goals are forfeiture of remaining funding request.
