The Florida Boys & Girls Clubs Opioid Awareness and Prevention Program. The Boys & Girls Clubs will work with all youth, but specializes in working with the most highly at-risk youth, those youth who are no longer simply at-risk but immersed in their risk behaviors in afterschool programs. The program will address the risks of and reduce the rates of youth opioid abuse / misuse through the BGCA's Opioid & Substance Use Prevention, featuring 29 evidence-informed prevention practices that will be integrated into mentor training and mentor-mentee activities, and resources to support a part-time prevention specialist position at each involved club. Other program as Positive Action is a system program. It provides guidance, care, evidence-based practice and resources that keep young people in school and out of trouble. Increase awareness about the dangers and addictive properties of opioids, including prescription medications through various platforms of social media and community events.
