1. Title of Project: Hurricane Michael - Panama City - Roadways & Drainage Infrastructure

4. Project/Program Description:

The project will restore residential roadways serving residential neighborhoods and Panama City collector roadways. The direct damages of Hurricane Michael on the city's roadways and related drainage resulted in significant unplanned infrastructure repairs and replacements. The project will include repairs from damages to roadway pavement, shoulders, and drainage from debris and removal operations. The most significant use of project funding will be repairs and full replacement of residential roadways that must be removed to make critical repairs water and sewer underground lines damaged by Hurricane Michael. A complete comprehensive assessment of the distribution of costs will be available from our engineering consultant tasked to itemize and help the city establish immediate needs priorities in conjunction with our water and sewer engineering consultants.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The primary goals are traffic safety and proper restoration of roadways that require removal of sections to make repairs to water and sewer systems. The needed primary rehabilitation methods include: Milling to remove distressed surface material and improve crowning of roadway; Leveling course to smooth un-even surfaces with or without milling; Structural Overlay, utilizing current FOOT "SuperPave" asphalt mix designs, to restore the structural load-bearing wearing surface; Based on geotechnical cores, additional methods may be needed in the construction; and Replacements from sub-surface to asphalt pavement due to critical repairs to water and sewer systems.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Repairs and rehabilitation of these roadways will include consideration of cores, milling to remove distressed surface material and improve crowning of roadway, a leveling course to smooth uneven surfaces, and a structural overlay, utilizing current FOOT "SuperPave" asphalt mix designs, to restore the structural load-bearing wearing surface. In certain residential neighborhoods, repairs to water and sewer systems will require complete rehabilitation from sub-surface to asphalt pavement and drainage. Additionally, certain residential neighborhoods will require extensive rehabilitation due to debris removal operations that created excessive stress and damages to roadway surfaces and shoulders and drainage.

c. What are the direct services to be provided to citizens by the appropriations project?

The immediate direct services will be safer roadways and restoration of essential water and sewer systems covered by the roadways.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served will be the general population at large plus traffic on collector roadways. It is difficult to project how many individuals are expected to be served, but reasonable to expect the entire community and Bay county will benefit. The City of Panama City serves essential functions to the region, including medical services, a major commercial corridor, including access to the Port of Panama City, and multiple federal, state, and county government functions. Safe, well-maintained roadways and stormwater systems are critical, particularly as they connect to county and state roadways and stormwater systems to prevent additional damage and/or flooding.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The greatest benefits will be restoration of Hurricane Michael damaged water and sewer systems in residential neighborhoods covered by roadway and restoration of drainage to reduce flooding. Outcomes can be measured by the number of roadway miles rehabilitated and number water and sewer systems restored that require roadway work.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Funding could be arranged on progressive draw-down of appropriated funds measured by various stages of roadway miles rehabilitated including but not limited to type of work planned and performed.
