- 4. Project/Program Description:

The City of Tallahassee and Leon County actively review and report mitigation needs through the Local Mitigation Strategy (LMS) plan. As part of the 2019 update to this plan, numerous projects have been identified as critical sites in need of hazard mitigation. The following projects have been identified as priorities for consideration. The first is a project to fortify communities and improve safety during disasters. Components include improving disaster resistance of existing housing through a pilot program, identifying populations at risk, and encouraging the establishment of community-based emergency shelters. The second project is to reduce flooding and improve floodplain management. Components of this project include, changes to the 25 and 100-year floodplains as well as funding for flood-related capital projects and acquisition of easements to maintain major ditches and canals.
