#### 4. Project/Program Description:

Nearly two dozen agencies, veterans' organizations, attorney associations and service providers have collaborated with FLORIDA STATE UNIVERSITY COLLEGE OF LAW to coordinate legal and related services to Veterans and their families in the Capital area. Hundreds of Veterans have sought our help and more than 200 attorneys have given their pro bono assistance through Veteran Stand Downs (2013-2018) and weekly walk-in legal clinics at the local American Legion Post 1~. in Tallahassee, and since spring semester 2018, weekly clinics staffed mostly by law students at the Tallahassee VA Clinic' itself. Additionally, we have periodic Drivers License workshops and advocacy to rehabilitate Veterans' suspended drivers licenses, often with multi-county and multi-state legal problem solving, community service, advocacy, and finally reinstatement and new job opportunities.

#### a. What is the specific purpose or goal that will be achieved by the funds requested?

The ongoing clinics will provide legal assistance "to hundreds of area Veterans and their families, as a collaborative model project for communities statewide; thousands of veterans are at risk of being homeless, many become homeless or partially disabled, and many more economically vulnerable. All they need are competent and caring researchers, paralegals, problem solvers and sometimes actual legal representation and advocacy.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The College of Law provides specific and invaluable instruction to law students on Veterans' legal issues (three semesters per year), volunteer attorneys and others in the multidisciplinary clinic teams meet with Veterans, and refer or represent individuals and families in a wide variety of legal entanglements, both local and in other jurisdictions around the state and country.

### c. What are the direct services to be provided to citizens by the appropriations project?

Research, multi-disciplinary intake sessions, referrals for jobs or housing or other services as neeced, and referrals-to-ofher., attorneys or in appropriate cases direct representation. Paralegals and students help track down missing documents, identify possible benefits, and the entire TVLC team works to remove

hundreds of obstacles to Veterans hoping to reinstate their drivers licenses, improve job and housing opportunities, etc.

  More than 200 individuals will be served among the region's veterans, especially targeting homelessness, economic vulnerabilities, disabilities, and various risks of becoming homeless.

Our collaborative structure ensures interagency communication and reviews of individual families' success, and" individuals' recovery, employability, etc. Stats are compiled by ongoing, confidential database entries after each legal intake and supplemental encounters with agencies, as well as with returning veterans.
