The purpose/goal is provide funds for Wakulla County to procure a reliable, secure first responder communication system for intake/dispatch of emergency calls and for Wakulla County first responders to be able to communicate with other federal, state, and local first responders.

 - Activities would be the intake and dispatch of emergency calls, as well as communication/coordination with other local, state, and federal first responders, so that appropriate, essential life saving services can be provided to citizens and visitors in need.

 - The targeted population is all citizens, visitors, and evacuees in the county. Wakulla County has an estimated population of 30,000 and many more visitors on a daily basis.
