Clients and families affected by autism and/or related disabilities receive care coordination, case management, direct assistance and support in the form of clinical consultations about best practices, resources and referrals to appropriate federal, state and local agencies, and direct assistance to schools their children attend, and workplaces and residential environments where they may work and live.

- b. What are the activities and services that will be provided to meet the intended purpose of these funds?
  - CARD's core services are: Individual and Direct Support to Clients and Families; Professional Programmatic Assistance to Schools and other entities; Training; and Public Education and Awareness.
- c. What are the direct services to be provided to citizens by the appropriations project?
  - CARD's core services are: Individual and Direct Support to Clients and Families; Professional Programmatic Assistance to Schools and other entities; Training; and Public Education and Awareness.
- d. Who is the target population served by this project? How many individuals are expected to be served?
  - Florida citizens with autism spectrum disorder or a related disability, along with their family members and the professionals who serve them. In addition, all 67 Florida school districts are partnered with a regional CARD center for training and technical assistance. Currently, over 50,000 families are registered with the statewide CARD program.

Each year, the CARD centers submit a project plan to DOE with specified deliverables per quarter and annually. Target deliverables are outlined by DOE in the RFA for the CARD Centers each year. Data on deliverables are reported quarterly to DOE through the Project Tracking System. DOE liaisons monitors each CARD center's performance quarterly.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Failure to meet quarterly deliverables may result in a withholding of funds. At times, amendments are submitted to address a change in planned deliverables as district and community priorities may change mid-year.
