4. **Project/Program Description**

CROS Ministries' Gleaning program is one of the largest food recovery programs in the State of Florida because of the proximity to local farms and the variety and quantity of produce we can recover. Launched in 2003, the program helps to increase the availability of fresh fruits and vegetables for the food insecure population in our region. With the help of distribution partners including the Palm Beach County Food Bank, Feeding South Florida and others, the recovered produce is added into the food supply to give to people in need. According to Feeding America, 20 billion pounds of fruits and vegetables are discarded on farms or plowed under. The USDA has estimated that 35 million pounds of food is needed annually to feed hungry residents in Palm Beach County. During the 2018-19 season, (November -July), 604,674 pounds of fresh produce was recovered, providing the equivalent of 503,895 meals. (Based on Feeding America's equation of 1.2 lbs. of food = 1 meal)

11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

CROS Ministries is a multi-county not for profit seeking matching state funds to increase the amount of pounds of fresh produce recovered from local farms that would otherwise go to waste and entered into the food system serving hungry children and families. CROS operates one of the largest food recovery programs in the State of Florida in collaboration with family farms and distribution partners.

b. What activities and services will be provided to meet the intended purpose of these funds?

CROS Gleaning will recover fresh fruits and vegetables that would otherwise go to waste and enter it into the food system serving hungry children and families. During the 2018-19 season, (November - July), 604,674 pounds of fresh produce was recovered, providing 503,895 meals to hungry residents in Palm Beach County. (Based on Feeding America's equation of 1.2 lbs. of food = 1 meal)

c. What direct services will be provided to citizens by the appropriation project?

Funding will enable CROS Ministries to recover an additional 200,000 pounds - 300,000 pounds of food. This will provide 166,667 - 250,000 meals to hungry residents in Palm Beach County. (Based on Feeding America's equation of 1.2 lbs. of food = 1 meal)

d. Who is the target population served by this project? How many individuals are expected to be served?

According to Feeding America, there are close to 200,000 residents in Palm Beach County struggle with hunger and have trouble putting nutritious food on the table. This is the population who benefit from our food recovery program, children, men, women, working families, seniors, veterans, the homeless, and people with mental and physical disabilities.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

1. To increase access of fresh fruits and vegetables to households who are food insecure. CROS Ministries will recover an additional 200,000 pounds - 300,000 pounds of food. This will provide 240,000 - 360,000 meals to hungry residents in PBC. (Based on Feeding America's equation of 1.2 lbs. of food = 1 meal). Outcome measurement - Total number of pounds of fresh produce provided to distribution partners and total number of meals provided to food insecure households through distribution partners. 2. To create skilled jobs in the Glades while countering farmland development. Funds needed to create these new positions. We will seek alternative funding to continue to pay for salaries going forward. Outcome measurement - number of jobs created. 3. To conduct a comprehensive study on how hydroponic agriculture facilities can increase fresh food availability, create skilled jobs in the Glades, and provide ongoing funding streams. Outcome measurement - completed study.
