The goal of the project is to prevent street flooding on Clearwater-Largo Road during seasonal summer rains and to comply with National Pollutant Discharge Elimination System (NPDES) regulations. This segment of Clearwater-Largo Road is a minor arterial roadway that transverses the hospital corridor between Morton Plant Hospital in the corporate city limits of Clearwater and Largo Medical Center (hospital) and the Largo Diagnostic Clinic in the medical arts district in the corporate city limits of Largo.

11. Program Performance

- a. What specific purpose or goal will be achieved by the funds requested?

Improved flood protection from seasonal summer rains along Clearwater-Largo Road, including reduction in pollutants, thereby improving the environment and quality of life. Reduction in puddling and street flooding will improve driving conditions for motorists and make conditions safer for pedestrians and bicyclists. Enhanced water quality in McKay Creek Basin.

- b. What activities and services will be provided to meet the intended purpose of these funds?

Reduction in the number and severity of sanitary sewer overflows caused by street flooding; reduction in street flooding; improved water quality treatment; and enhanced water quality in the McKay Creek Basin.

- c. What direct services will be provided to citizens by the appropriation project?

Improved water quality treatment; enhanced water quality in the McKay Creek Basin; creation of temporary construction jobs; generation of small business activity during the construction phase of the project; and increased development and investment opportunities as a result of the project.

- d. Who is the target population served by this project? How many individuals are expected to be served?

Residents, investors, and business owners in the community redevelopment district and qualified opportunity zone area, including hospital and medical providers located along Clearwater-Largo Road between Morton Plant Hospital in Clearwater and Largo Medical and Largo Diagnostic Clinic in Largo. Approx. 3,000 persons reside in the area and 874 land parcels on over 248 acres.

- e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Creation of new development and investment opportunities through qualified opportunity zone investment funds; improved infrastructure for existing and new small businesses and small scale manufacturers. Outcomes measured by analysis of increased business activity (e.g. volume/value of building permits) and water quality monitoring.

- f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Construction contractors that contract with the City of Largo are required to purchase a surety bond at 100% of the project cost. Payments may be withheld pending satisfactory completion of the contracted project.
