4. **Project/Program Description**

This project includes survey, design, permitting, construction, and construction engineering and inspection (CEI) for roadway resurfacing and drainage improvements. This would include resurfacing a 0.3 mile segment of roadway consisting of two 12' travel lanes south of Pennsylvania Street and two 11' travel lanes with 10' of parallel parking along the east side of the roadway for the portion of Etheridge Street north of Pennsylvania Street. In addition, curbs and gutters would be replaced along both sides of the roadway and the existing drainage system would be improved to alleviate flooding issues that the business district is currently experiencing. The existing sidewalk would need to be replaced where necessary in order to construct the drainage improvements or meet ADA requirements. Thermoplastic striping and traffic signage and striping would be installed to improve safety. Etheridge Street is a central component of the City of Bonifay's roadway system.

11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The purpose of this project is to provide an improved roadway and drainage system along Etheridge Street to prevent flooding and improve safety. The existing curbs and gutters, and inlet system have deteriorated over time. Many of the existing curb inlets and side drains have collapsed which continues to cause flooding issues along the southern portion of the roadway.

b. What activities and services will be provided to meet the intended purpose of these funds?

This project will require engineering design and inspections and utilization of various construction vendors to complete and ensure that the funds are spent in the most beneficial way to address the most needed repairs and improvements.

c. What direct services will be provided to citizens by the appropriation project?

Currently, there are no pavement markings provided along Etheridge Street, which is a concern for safety. Thermoplastic striping and traffic signage and striping would be installed as a part of this project to improve the safety for the citizens. Additionally, ADA improvements such as sidewalk and curb ramps would be required where there are none existing.

d. Who is the target population served by this project? How many individuals are expected to be served?

Etheridge Street is a local road that parallels SR 79. Bonifay city hall and Holmes County public library, as well as many other businesses, abut this roadway producing a much higher volume of traffic than typically seen on other local roads. Therefore, improvements made to the roadway would benefit the citizens of the City of Bonifay and Holmes County: more than 2,700 citizens.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Protection of the general public would be accomplished by providing improved drainage which would prevent ponding and flooding of the roadway and downstream areas within the city. Replacing the deteriorating drainage structures would prevent the potential for collapse or failure of the existing inlet and pipe system located within the roadway. Improved signage and striping would provide better visibility and safety for persons traveling along the roadway. Construction would provide immediate job opportunities for the area. A stormwater model would be prepared by a professional engineer to evaluate the pre- and post-development drainage conditions as a measure of outcome. A survey prior to construction and an as-built survey post-construction would be completed to evaluate the outcome of safety and visibility. The number of workers present during construction would be a measure of job creation.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

The city would award the contract through a bid process. The bid documents would address how liquidated damage costs for project overruns would be handled. The bid documents would also require that the selected contractor provide performance and payments bonds to the city, and a 10% retainer would be withheld until all issues were resolved or corrected.
