a. What specific purpose or goal will be achieved by the funds requested?

The County seeks to build an economical fire station to provide the fastest response time to our citizens in the central unincorporated portions of Bradford County. The new fire station will have three vehicle bays and sleeping quarters to house up to six fire and EMS employees. Financial assistance is requested for the construction of the new fire station. The County will pay for the design.

b. What activities and services will be provided to meet the intended purpose of these funds?

Firefighting and emergency response related services for community and general public.

c. What direct services will be provided to citizens by the appropriation project?

Firefighting and emergency response related services for community and general public.

d. Who is the target population served by this project? How many individuals are expected to be served?

This zone covers the Raiford prison which houses nearly 1500 inmates alone. In addition, this coverage area where the station lies central of Bradford County has a census of over 27,000.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Protect the general public from harm. The number of fires, departments response time to fires, number of deaths from fires, dollar amount of property damage from fires. The fire department issues a report on all fire occurrences. We will collect this data at six and 12 months and compare it to before the new fire station was built.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

We would have to deploy our firefighters from a fire station that's farther away from central Bradford County. The response times will take longer which may result in increased property damage from fire or loss of life.
