11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Reduce violent / destructive behavioral concerns through in-school prevention and intervention program. The scientific base linking social and emotional learning to students in school success is the combined effort to promote academic, social, and emotional learning. There is general agreement, that it is more successful to the student, school and community, if a youth's school environment fosters social-emotional development. It is also proven that the lack thereof, often is a contributing factor to the fragmented mental approach of youth, which lends itself to be a contributor to enhancing drugs, violence and lack of self-governance.

b. What activities and services will be provided to meet the intended purpose of these funds?

Duval Leaders of Tomorrow will be located in the schools providing behavioral modification training through 1. Character Education, Social Skills and Behavioral Modification 2. Mentorship 3. Duval Leaders of Tomorrow will also host a STOP THE VIOLENCE AGAINST YOUTH Event. 4. Prevention of Bullying via Social Media.

c. What direct services will be provided to citizens by the appropriation project?

Behavioral modification, talk/group meetings and additional behavioral modification teachings and techniques to and with the teachers.

d. Who is the target population served by this project? How many individuals are expected to be served?

Students who pose a risk for continual at risk behaviors. These students are identified by Duval public school teachers and guidance counselors

Expected outcome is to:

- 1. equip these students with the tools they need to make better decisions,
- 2. to redirect and express themselves through good decision making verses through anger, and
- 3. to lessen the return to alternative schools like Grand Park.
