	The Town received \$500,000 in legislative appropriation in FY2018-19 and over \$1.55 million from the FEMA Flood Mitigation Assistance (FMA2017) Grant Program to assist in funding the West Lakes Drainage Improvements Phase III Project. This Project is under construction with an estimated completion in 2021. The Phase IV Project continues the flood mitigation activities in the West Lakes community between NW 89th Avenue and NW 92nd Avenue, from NW 153rd Terrace to NW 152nd Lane boundaries, connecting to the storm water main line on NW 89th Avenue leading to the outfall. The Town applied to the FEMA FMA2020 Program for the federal share to assist in funding this Phase IV Project.

a. What specific purpose or goal will be achieved by the funds requested?

The specific purpose that will be achieved by the funds being requested are a reduction in localized flooding, standing rainwater, and the probability of mosquito-transmitted diseases to the public.

b. What activities and services will be provided to meet the intended purpose of these funds?

Flood mitigation activities, including the design, permitting, and construction of the drainage system installation of drainage pipes, exfiltration trenches (French Drains), and asphalt restoration between NW 89th Avenue and NW 92nd Avenue, from NW 153rd Terrace to NW 152nd Lane boundaries.

c. What direct services will be provided to citizens by the appropriation project?

Flood mitigation activities to further reduce or eliminate the risk of repetitive flood damage in the West Lakes community.

d. Who is the target population served by this project? How many individuals are expected to be served?

Target population served by this project is the West Lakes residential community in Miami Lakes. The project will directly impact 34 homes within the project limits.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Expected benefits include reduced localized flooding, increased drainage capacity, improved stormwater management, eliminated standing rainwater, reduced probability of mosquito-transmitted diseases to the public, and reduced impact to property and life. Outcome will be measured by field inspection and documentation of rainfall events.
