#### 12. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

People with disabilities, many forgotten during the COVID crisis, receive the tools needed to return to work, advance on their chosen career track, and mitigate skill set loses caused by unemployment and isolation.

MTC's elevated employment training programs align with four high-growth sectors of Florida's economy: technology, manufacturing, healthcare and hospitality. Each track is taught by college level educators, and industry professionals. Graduates earn globally recognized post secondary credentials demonstrating to a future employer that the job seeker has the skills and emotional intelligence needed for employment.

Neurodiverse work environments that are flexible and open to the talents of all qualified individuals, including those with disabilities, actually promote workplace success for everyone.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Get Back to Work is an innovative solution to the sky high unemployment rate following the COVID-19 crisis. Individuals with disabilities and other barriers to employment have the opportunity to earn post-secondary credentials at two in-person locations or online through customized instruction adapted to their unique learning styles. Business partners involved in the program's curriculum assist in workplace readiness and employment outcomes. MTC's elevated training is an evidenced based "bundled" approach to providing short term; post-secondary education leading to career opportunities; basic financial skills education; career employment counseling; case management and /or workplace supports to help adults with disabilities obtain and maintain employment, complete career ready post-secondary education and/or increase knowledge of financial stability concepts. Long-term follow services ultimately allows them to earn, keep and grow assets and live financially secure lives.

#### c. What direct services will be provided to citizens by the appropriation project?

Elevated secondary education, geared to the varying learning styles of people with disabilities from Autism to developmental disabilities, and those who are deaf, or blind is a game changer in the lives of those who come through the program, leading to more opportunities, higher wages, and career advancement.

The program includes:

o Education: students are taught and certified in globally accredited industry standards by college educators or industry experts. On the job training for students helps master those work related tasks that they may encounter at their job. Professional development classes teach and explore different career opportunities and employment paths to help students, including youth unsure of their potential, understand their own vision of a career.

o Employment: Customized job development, job placement coaching transitions students from classroom to work site. o Ongoing Support: Follow along support ensures future success, employer confidence and career advancem

#### d. Who is the target population served by this project? How many individuals are expected to be served?

MTC programs are unique in the Tampa Bay area. MTC program partners such as The Learning Academy at the Center for Autism & Related Disabilities (CARD) at the University of South Florida, Disability Resource Hub, and Lighthouse of Pinellas, offer related and complementary programs and services. But the focus on globally recognized, industry-certified training for this discrete population of persons with disabilities in the Tampa Bay area is only found at MTC. This unique and innovative model enables people with disabilities who became unemployed during of the crisis and who might otherwise remain stagnant as entry-level workers to develop their skills and move into higher-paying jobs as a concrete strategy for returning to the workforce, career advancement and climbing the ladder to career success, independence and full equity.

"When everyone works, everyone benefits." For FY21, MTC has capacity for 144 participants to achieve one or more of the following: graduate from a short term postsecondary certificate program, obtain employment and/or increase access in the community. Increased financial independence leads to decreased reliance on State and Federal benefits from food stamps to SSI, lessening the burden on taxpayers. In response to the COVID crisis, MTC opened highly specialized training in sanitation, and logistics (central to the increase in online shopping),to clients at Feeding TampaBay, Lighthouse for the Blind Pinellas, and CareerSource Tampa Bay. MTC is one of only two certified logistics testing sites in the area and is a certified Microsoft testing site. MTC uses grading, evaluation and assessment tools to measure progress, such as class quiz and final exam scores class attendance and participation. Students need a passing grade of 70% to earn certificates from most accrediting bodies.
