4. The CPALMS resource for teachers, students, and families in arts education is increased (ACE Collection).

The target population served by this project are public schools and other public-funded educational environments who are studying dance, music, theatre, and visual art.

There are currently just over 2,750,000 students in Florida's schools, K-12.
