4. Project/Program De	escription					
The proposed project includes new roadway construction, and road reconstruction of the roadway segment along NW 97th Ave., the creation of a pedestrian-bike share path, sidewalks, roadway striping and landscaping as well as drainage improvements for flood protection as well as public outreach. Roadway: The proposed roadway improvements and road reconstruction along NW 97th Ave. will consist of widening, reconstruction, and milling and resurfacing of about 1,600 LF of a 3-lane roadway to two twelve-foot-wide vehicular travel lanes, two-foot-wide green bicycle lane, two feet of curb and gutter, and a ten-foot landscape buffer along the west side, as well as a six-foot-wide sidewalk to provide pedestrian connectivity. Pedestrian: The proposed improvements incorporate five-foot-wide, continuous sidewalks as recommended in the Town of Medley Multimodal Mobility Plan. Drainage System: The roadway reconstruction will modify the profile of the road and the stormwater drainage system retrofit.

a. What specific purpose or goal will be achieved by the funds requested?

The main objective of this project is to improve roadway connectivity, existing conditions, and drainage to advance services to the local residents including transportation and mobility by providing pedestrian sidewalks and bicycle lanes, drainage and flood protection.

b. What activities and services will be provided to meet the intended purpose of these funds?

The proposed project includes new roadway construction, and road reconstruction of the roadway segment along NW 97th Ave., the creation of a pedestrian-bike share path, sidewalks, roadway striping and landscaping as well as drainage improvements for flood protection as well as public outreach. Roadway: The proposed roadway improvements and road reconstruction along NW 97th Ave. will consist of widening, reconstruction, and milling and resurfacing of about 1,600 LF of a 3-lane roadway to two twelve-foot-wide vehicular travel lanes, two-foot-wide green bicycle lane, two feet of curb and gutter, and a ten-foot landscape buffer along the west side, as well as a six-foot-wide sidewalk to provide pedestrian connectivity. c. What direct services will be provided to citizens by the appropriation project?

Due to deterioration and the serious existing conditions in the project area, this project is critical for the safety of local residents as well as the economic growth and job creation for the Town of Medley. The Town of Medley is requesting funding for roadway and drainage improvements, including the reconstruction of the roadway, milling, resurfacing, and widening of the existing pavement to accommodate curb & gutter, signage, pavement markings as well as pedestrian sidewalks and bicycle lane.

The project also includes drainage improvements with additional catch basins, swales and exfiltration trenches and other infrastructure improvements for water quality.

d. Who is the target population served by this project? How many individuals are expected to be served?

The general public and businesses will be served by this project. We anticipate more than 800 individuals to be served by this project.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This project promotes the economic growth of the industrial redevelopment of an under-utilized area within the Town of Medley as it will increase business opportunities and bring social and economic benefits to the local residents as well as visitors. This project will improve the Town's road network, will allow the easier flow of traffic, promote multimodal mobility, emergency evacuation, and improve connectivity and accessibility for the transportation of goods and the circulation of heavy equipment. The benefits of this project will be measured by improving the socio-economic impact to local residents and visitors and commercial/industrial activity by assessing time savings in traveling and the impact of the roadway improvements to the public based on the number of users, the traffic volume and density as well as the redirection of traffic from other roads.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The contract will have standard language that will include liquidated damage or debarment.
