The Town is requesting legislative appropriation to fund the NW 159th Terrace Drainage Improvements Project. The project is located in the Royal Oaks Estates Domingo residential community and just north of the Bob Graham Education Center, located at 15901 NW 79th Avenue in Miami Lakes.

This project includes the design, permitting, and construction of the drainage system comprised of drainage pipes, exfiltration trenches (French drains), and asphalt restoration on NW 159th Terrace, from NW 79th Avenue to NW 77th Place. The estimated project cost is \$400,000.
