## 4. Project/Program Description

Construction of a permanent stationary pump and well at Reed Canal Stormwater Pond. The well is the structure where the pump is positioned and water levels are managed. The stationary pump will provide greater flood protection services for the residents of the City of South Daytona. A stationary pump will provide a safer and more reliable system that will be retrofitted to be monitored remotely during storm events when Public Works and Public Safety employees cannot safely travel to the pump and related equipment located at this site. A permanent pump will alleviate the risk of a diesel fuel spill associated with the temporary pump.

##### a. What specific purpose or goal will be achieved by the funds requested?

Flood protection and control are the primary goals. Reed Canal Pond also treats stormwater runoff prior to it entering into the Halifax River and Reed Canal Basin Watershed. The existing pump is a mobile unit and utilizes diesel fuel. A permanent pump will provide more reliable flood protection control without the use of diesel fuel and with the ability to remotely control the unit during storm events.

##### b. What activities and services will be provided to meet the intended purpose of these funds?

Flood protection.

Flood protection and removal of diesel fuel powered pump that creates noxious fumes and causes potential for introduction of fuel and oil to surface waters.
