SCF received \$5.3M in Cares Act funds for PPE including masks, gloves, acrylic shields for classrooms and high traffic areas, enhanced cleaning and disinfection, technology, faculty staffing reflective of reduced class size and online course delivery where appropriate, and other Coronavirus-related relief. Half of the funding was directed to students impacted by the pandemic.

This funding will allow SCF to increase capacity in high-demand existing programs and add new targeted programs to quickly return community members impacted by the COVID-19 pandemic to the workforce.

b. What activities and services will be provided to meet the intended purpose of these funds?

Skill Up Manatee-Sarasota will focus on participants who are either furloughed, unemployed, or employed but at risk of losing their job due to automation or disruption of the local economy due to COVID-19. Skill Up Manatee-Sarasota will allow SCF to build on the momentum created by the "Get Credentialed, Get Noticed!" initiative to continue to help Manatee and Sarasota County residents return to the workforce.

c. What direct services will be provided to citizens by the appropriation project?

Skill Up Manatee-Sarasota will enable economic and social mobility for Floridians seeking high-skill, high-wage jobs in our region. This will allow SCF to increase its capacity to enroll and graduate students in short-term career education programs that are aligned to high-skill, high-wage occupations. This initiative will also fund scholarships for students, career coaching, placement services, and other career services.

d. Who is the target population served by this project? How many individuals are expected to be served?

Skill Up Manatee-Sarasota will focus on participants who are either furloughed, unemployed, or employed but at risk of losing their job due to automation or disruption of the local economy due to COVID-19. The program will target at least 150 students.
